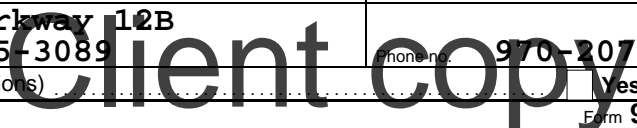

Fort Collins Cat Rescue & Spay/Neuter Clinic provides a shelter for cats and kittens that have been abandoned or surrendered by their previous owner. All cats taken into the shelter receive thorough medical care including but not limited to: spay/neuter, vaccines, and deworming before going up for adoption. In addition, the shelter provides assistance for feral cats, education for the community and pet food assistance for struggling pet owners.

Fort Collins Cat Rescue & Spay/Neuter Clinic provides low-cost spay/neuter procedures for dogs and cats belonging to the general public and even further reduced spay/neuter procedures for dogs and cats belonging to other animal shelter and rescue organizations. In addition, low-cost vaccination clinics are provided twice per month for pets belonging to the general public. The clinic also offers a PAL Program in which low-income community members can apply for free spay/neuter procedures for their pets.

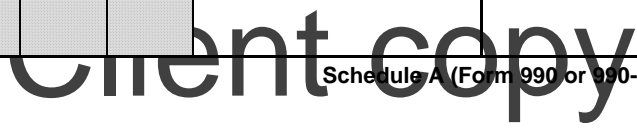

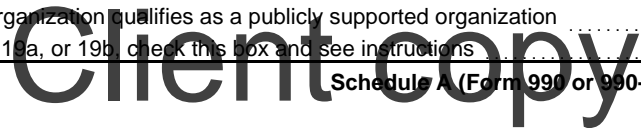

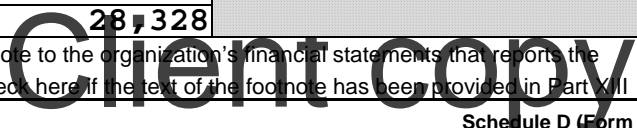
